## A RESOLUTION PERTAINING TO APPROVAL OF BUDGET ADJUSTMENT #BA139 TO SUPPLEMENT BUDGET ADJUSTMENT #BA078

WHEREAS, Title 5 of the <u>Code of Public Local Laws of Calvert County</u>, <u>Maryland</u>, being Title 5 of <u>Article 5</u> of the <u>Code of Public Laws of Maryland</u> (hereinafter, the "<u>Code</u>"), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the "Board of County Commissioners") to adopt the Annual Budget and Appropriation Act each year;

**WHEREAS**, the Board of County Commissioners has the authority pursuant to Section 5-103 of the <u>Code</u> to enact certain budgetary adjustments by Resolution;

WHEREAS, the County has been approved in fiscal year 2016 to receive revenue from loan proceeds from the Maryland Department of the Environment with the intent to use this revenue to cover costs related to the construction of the Chesapeake Heights / Dares Beach Water Treatment project;

WHEREAS, the Board of County Commissioners has been advised by the Department of Finance and Budget that it desires to utilize these funds for funding the Chesapeake Heights / Dares Beach Water Treatment project;

WHEREAS, the Board of County Commissioners did adopt Budget Adjustment No. BA078 by Resolution 30-16 following a duly advertised public hearing and, to correct an administrative error, now desires to increase the Maryland Department of Environment loan appropriations by \$83,000 more than reflected in Resolution 30-16 to ensure there are funds available to complete the construction of the aforementioned project;

WHEREAS, the Board of County Commissioners finds that it is in the best interest of the public health, safety and welfare of the citizens of Calvert County, Maryland to adopt Budget Adjustment #BA139 as set forth in Exhibit "A," attached hereto and made a part hereof.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners of Calvert County, Maryland, hereby approves and enacts the appropriations and expenditures set forth in Budget Adjustment #BA139 in the amount of \$83,000, a copy of which is attached hereto as Exhibit "A" and made a part hereof.

**BE IT FURTHER RESOLVED,** by the Board of County Commissioners of Calvert County, Maryland that the Calvert County Capital Improvement Program for FY2017, as amended hereby, shall remain in full force and effect.

**BE IT FURTHER RESOLVED,** by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary.
